

presents or by operation of law or otherwise howsoever in relation to these present), and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained.

NOW THIS INDENTURE WITNESSETH AS FOLLOWS :

1. Name :

The Name of the trust hereby established shall always be **"NPS Trust"** and the same shall never be changed.

2. Office :

The Principle office of the trust shall be at **" NAVNEET HOTEL "**
Sahijana Road ,post -Garhwa ,Ps.- Garhwa, Dist -Garhwa (Jharkhand).

3. Jurisdiction :

The Jurisdiction of the trust shall extend to the dist.- Garhwa , state of Jharkhand.

4. Aims and Objects

That the objects which this is established are:

- (a) To establish a non profit educational organization devoted to the whole some upliftment of poor and down trodden class and other class of society and to give them professional, technical and job oriented education in a charitable way.
- (b) To establish, develop, maintain and granted aid in cash or in kind to school, colleges, nursing institutions, Vocational Course Programme and technical and professional colleges, child welfare, and /or such other similar Charitable institutions in India for the benefit and use of general public.
- (c) To establish, run, support and grant aid or other financial assistance to school, college, libraries, reading room, universities, laboratories, research and other institutions of the kind like nature in India, for use of the students and the staff and also for the development and advancement of education of knowledge among the public in general .
- (d) To establish, maintain and run studentships, scholarships and render other kind of aid to students including supply of books, stipends, medals, and Other incentives to study, without distinction as to caste colour , race creed or sex.

(e) To promote, establish, support, maintain or grant aid to institution for the promotion of science, literature, music, drama and fine arts, for the preservation of historical monuments and for the research and other institution in India, having similar objects for the benefit of the public in general.

(f) To establish, maintain or grants aid to homes for aged, orphanages or other establishment for the relief and help and help to poor, needy and destitute people, orphans, widows and aged persons.

(g) To establish and develop institutions for the physically handicapped and disabled or mentally retarded persons and to provide them education, food, clothing or other help.

(h) To grant relief and assistance to the needy victims during natural calamities such as famine, earthquake, flood, fire, pestilence, etc. and to give donations and other assistance to institutions, establishments or persons engaged in such relief work.

(i) To grant aid or render assistance to other public charitable trusts or institutions.

5. Trust Properties

That, in order to effectuate his aforesaid desire, these, the founder has set apart and handed over to the trustees out of his inherited property, a sum of 1,00,000.00 (Rupees One Lakh only) (hereinafter called the "Trust fund" which expression shall include cash and any other property or investments of the kind whatsoever into which the same or any thereof might be converted, invested or varied from time to time or which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these present), and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained.

6. Board of Trustees :

That for the furtherance of the objects of the trust, the founder trustees shall have the following power :

(a) To accept any donation, contribution, grant or subscription in cash or kind, from any person(s), body of or trust/society, Corporate Sector, Government with or without conditions.

- (b) To apply the whole or any part of the income of the trust, or the trust fund or accumulations thereto, to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time
- (c) To convert and deal with the trust property and/or any investment for the time being.
- (d) To open account in the name of the trust, trustee and/or Institutions run/conducted by the trust with a Bank or Bank, to operate such account and to give instructions to the bank and to provide for opening and operation of such account by one or more of the trustee or by an agent appointed by the Trustee.
- (e) To set apart and/or allocate the whole or a part of the income or the corpus of the Trust Fund or part thereof for any of the objects of the Trust.
- (f) To accept any Loan or Advance from any person(s), body of persons or trust, bank financial institution with or without conditions.
- (g) The Trustees shall be accountable only for such money, stock and funds as shall actually come into their hands and a trustee shall not be answerable or accountable for neglects, default, acts or omission of the other Trustees or other person with whom the trust properties have been kept.
- (h) The Trustees will not be entitled to receive any remuneration but the Trustees may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.
- (i) The number of trustees shall not be less than two and more than seven. If the number of trustees shall fall below two, the trustees shall not, except for the purposes of filling any vacancy, act so long number is below the said minimum.
- (j) Every trustee will be at liberty to resign on giving one month's notice of his intention to do so.
- (k) The founder trustee shall have right to sell/dispose of, let out, any property of the Trust with the consent of other trustees for the benefit of the trust.
- (l) That the Founder trustee shall hold office for life and shall name the successor during his lifetime to the post of Founder. In absence of nomination, the legal heir shall be entitled for the post of Founder.
- (m) It is expressly declared that no part of the Trust property or its income or accretion thereto shall applied for any purpose outside India or for any purpose which is not a charitable purpose in law and all Provisions hereof shall be construed accordingly.

7. Meeting:

- (i) The management committee may ^{from} time to time frame rules for the conduct and regulations of the meetings of trustees. In the absence of such regulations two/third of the total trustees shall form a quorum for a meeting.

- (ii) The trustee may meet together as and when they may think necessary, but they shall hold at least three meetings a year.
- (iii) The quorum for the meeting of the trustees shall be one third of the trustees. If within half an hour of the time appointed for a meeting a quorum is not constituted, the meeting shall stand adjourned for an hour of the time appointed for the meeting the members present shall constitute the quorum.
- (iv) The trustee may pass a resolution by circulation such resolution passed whether by majority or unanimously by circulation amongst the trustees shall be equally valid and shall be construed as if passed at a meeting duly called and conveyed for the purpose and such resolution shall be entered by the chief managing trustee in the minute book of the meetings of the trustee.
- (v) The notice for the meeting shall be delivered personally or sent by post the trustees at least 10 day prior of the date of the meeting and at least five day in the case of an adjourned meeting. The notice must indicate the place, date and hour thereof as well as the time of agenda.
- (vi) The meeting shall not discuss or decide on any matter which are not included in the agenda save and except with the permission of the chief managing trustee.
- (vii) The meeting shall be presided over by chief managing trustee and direct the meeting of the trustees. But in any meeting the chief managing trustee is not available to meeting. The trustees presents shall elect amongst themselves a president for the the meeting. The decision of the meeting shall be recorded in minutes, entered into a special book maintained for the recorded in minutes, entered into a special book maintained for the purpose duly signed by the president of the meeting.
- (viii) The trustee shall act according to the decision of the majority of the trustees. When the trustees are not unanimous, the chief managing trustee (chairman) shall have the casting the election of trustees shall be taken by show of hand or secret ballot as the chairman may desire by majority of the votes of the members present.
- (ix) The chief managing trustee shall be executive officer of the council of trustees. He or she shall carry on the administrative work of the trust. Receive all letters and document of addressed to the trust prepare correspondence and keep all books and record of the trust. He shall collect all dues to the trust and effect all its payments, keep appropriate

records and books and help the council of trustees in financial administration of the trust.

8. Financial Year

The entire financial power is vested in the Management Committee or the person authorized by it.

Founder trustee shall be generally responsible for proper maintenance of the account of the trust. The balance sheet and profit & loss account of the trust shall be prepared from 1st April to 31st March every year. The account of the trust shall be audited by the Chartered Accountant appointed by the Management Committee.

9. Bank Account

The founder trustee shall hold have superintendence over the affairs of the Trust and shall have in particular the power to operate the bank account of trust jointly with one of the other trustee as may be decided by the board of trustees.

The operation of the account of the institution under its control shall be decided by the Management Committee.

10. Books of Account

The founder trustee shall be responsible for account, papers and documents including voucher, receipt book, etc.

11. Amendment:

The amendment in this trust deed shall only be effected if the same is approved by three fourth majorities of the trustees. However, any amendment to the trust deed will have to be reported within 7 days to the director, employment and training, Govt of Jharkhand.


